Course Information

Course 300 Credit Points

Core units 100 Credit points
A set of compulsory units you MUST complete as part of your Course.

First Major units 100 Credit points
A structured set of 8 units or 100 credit points in a field of study specific to your course.

Advanced Minor units 50 Credit points
A structured set of 4 units or 50 credit points which builds upon your first major.

Component Units 50 credit points
Can be completed from a combination of the following:

MINOR
A structured set of 4 units or 50 credit points from a field of study which you can choose in addition to a first major.

ELECTIVES
A standalone unit from any study area.

Professional Placement 50 / 100 Credit points
