### Admission criteria

#### A. Applicants with recent secondary education (within past three years)

##### ATAR

This course uses the ATAR as part of its selection considerations.

Guaranteed ATAR: if you receive an ATAR of 85 or higher and meet all the essential requirements for this course, you will be guaranteed an offer.

##### Educational history

An applicant's entire academic history, including ATAR results, will be considered for entry into this course.

##### Selection rank adjustments

Selection ranks for this course will be calculated based on your ATAR with adjustments to overall study scores based on subjects studied, location of your home address, SEAS application, and participation in Swinburne's Early Leaders program. ##### Subject Adjustments

A study score of 25 in any Business, any Humanities, any Information Technology, any LOTE or any Mathematics equals 2 aggregate points per study. Overall maximum of 12 points.

##### Meeting course prerequisites

VCE units 3 and 4: a study score of at least 25 in any English (except EAL) or at least 30 in English as Alternate Language (EAL) or equivalent.

An applicant's entire academic history from the past seven years, including complete and/or incomplete post-secondary VET studies, will be considered for entry into this course. Only graded results will be considered.

### D. Applicants with work and life experience

#### Entire academic record

This course uses an applicant's entire academic record as part of its selection considerations, including an applicant's ATAR results from the last seven years can be considered for entry into this course.
